STEP 1: Please complete all sections of the security transfer form below.

For privacy reasons, your broker cannot disclose your name to us, so please complete the Donor Information section. Your advisor/broker will provide you with the CUSIP #.

STEP 2: Please notify the Nova Scotia Nature Trust.

Fax or mail a copy of the completed transfer form to us. This step is important because securities are transferred into our account without your name. We value every gift and want to provide you with an accurate tax receipt and appropriate recognition to honour your donation.
